Successes during 2024 include:

- Submitting monthly articles in Gisborne Gazette to gain further community awareness.
- Partnered with PS My Family Matters to deliver monthly walks and morning teas (supported by Neighbourhood Houses Victoria) to support local carers in the area.
- Partnered with Macedon & Mount Macedon Community House (via an MOU) to deliver Permaculture, Digital Device Know How, Pottery Workshop and Responsible Serving of Alcohol (RSA).
- Delivered Barista training at Romsey Neighbourhood House.
- Developed new partnership with Gisborne Foodbank to deliver free community morning tea's.
- Partnered with Intereach to deliver a Free Aged Care information session
- Partnered with Anglicare Victoria to deliver their Energy Assistance Program
- Partnered with Regional Victorian's of Colour to deliver their Moving Feasts program.
